BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO, THAT:

SECTION 1: A contract with Rumpke Waste Collection and Disposal Systems is approved for a three year period, beginning April 1, 1994 and concluding March 31, 1997.

SECTION 2: The Village of South Bloomfield will process the residential and business billing for this service.

SECTION 3: Rumpke will invoice the Village of South Bloomfield in the amount of \$1881.00 per month for residential waste removal service (342 units at \$5.50 per unit per month) This includes Scioto Estates, Inc. and Janet Fout's Trailer parks. The Village of South Bloomfield will be billed \$859.00 per month for commercial waste removal service (18 commercial units based on commercial price list); a total of \$2740.00 per month.

SECTION 4: All Village municipal buildings will be serviced on a weekly basis at no additional cost. Containers for the Village annual spring cleanup will be provided at no additional cost.

SECTION 5: Every single family home dwelling in the Village of South Bloomfield must utilize the trash pickup by Rumpke and pay the trash bill. Bills will be sent out quarterly for residential pickup and monthly for business customers.

SECTION 6: Residents will be billed \$5.50 per month plus \$1.00 for billing costs. Senior Citizens and disabled (persons on disability) will be billed \$5.50 per month plus \$.50 for billing costs. The age of 62 years will be considered Senior Citizen for this purpose. Business customers will be charged \$1.00 per month also.

SECTION 7: The Mayor and Clerk-Treasurer will be granted authority to sign necessary documents relating to said agreement.

SECTION 8: This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of said Village for the purpose of waste disposal.

SECTION 9: This resolution shall take effect April 1, 1994.


