WHEREAS, ON THE 20TH DAY OF JANUARY 2009, THE VILLAGE OF SOUTH BLOOMFIELD ENACTED LEGISLATION WHEREIN THE VILLAGE AGREED TO COMPLY WITH ALL THE TERMS AND CONDITIONS OF AN AGREEMENT WITH THE DIRECTOR OF TRANSPORTATION FOR THE PURPOSE OF PURCHASING OF ROAD SALT; AND

WHEREAS, THE AGREED SUM THAT THE VILLAGE COMMITTED TO COMPENSATE THE DEPARTMENT IS ESTIMATED TO BE 10 TONS OF SALT @ \$75.00 = \$750.00.

WHEREAS, THE DIRECTOR OF TRANSPORTATION HAS APPROVED SAID LEGISLATION PROPOSING COOPERATION AND HAS EXECUTED AN AGREEMENT (ODOT CONTRACT #15500) COMMITTING TO MAKE AVAILABLE 500 TONS OF SALT FOR THE VILLAGE TO OBTAIN FROM AN AGREED LOCATION.

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE: THE ESTIMATED SUM, OF \$750.00, IS HEREBY APPROPRIATED FOR PURCHASE OF ROAD SALT AS DESCRIBED ABOVE AND THE FISCAL OFFICER IS HEREBY AUTHORIZED AND DIRECTED TO ISSUE AN ORDER ON THE TREASURER FOR SAID SUM UPON THE REQUISITION OF THE DIRECTOR OF TRANSPORTATION TO PAY THE COST AND EXPENSE OF SAID PURCHASE.

SECTION TWO: THAT THE VILLAGE ENTER (OR HAS ENTERED) INTO AN AGREEMENT WITH THER DEPARTMENT, AND THE VILLAGE OF SOUTH BLOOMFIELD BE, AND IS HEREBY AUTHORIZED TO EXECUTE SAID AGREEMENT, PROVIDING FOR THE PAYMENT OF THE VILLAGE THE SUM OF MONEY SET FORTH HEREIN ABOVE FOR THE PURCHASE OF ROAD SALT.

SECTION THREE: THAT THE VILLAGE SHALL TRANSMIT TO THE DIRECTOR OF TRANSPORTATION A FULLY EXECUTED COPY OF THIS RESOLUTION.

SECTION FOUR: THAT THIS RESOLUTION SHALL TAKE EFFECT AND BE IN FULL FORCE FROM AND AFTER THE EARLIEST PERIOD ALLOWED BY LAW.

AN EMERGENCY RESOLUTION TO AWARD TRASH CONTRACT FOR THE VILLAGE

WHEREAS, IT HAS BECOME NECESSARY TO AWARD A EXCLUSIVE CONTRACT FOR THE HAULING OF RESIDENTIAL AND COMMERCIAL TRASH IN THE VILLAGE OF SOUTH BLOOMFIELD,

THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO, THAT,

SECTION 1. LOCAL WASTE SERVICES, 1300 S. COLUMBUS AIRPORT ROAD, COLUMBUS, OHIO 43207, BE AWARDED AN EXCLUSIVE CONTRACT TO PICK UP TRASH FOR ALL RESIDENTIAL AND COMMERCIAL CUSTOMERS LIVING IN THE VILLAGE OF SOUTH BLOOMFIELD.

SECTION 2. PICKUP SERVICE FOR RESIDENTIAL WILL BE WEEKLY. COMMERCIAL CUSTOMERS WILL BE PICKING UP ACCORDING TO THEIR REQUIREMENTS.

SECTION 3. YARD WASTE, RECYCLABLE MATERIALS, LARGE AND BULKY ITEMS, AND CHRISTMAS TREES WILL BE COLLECTED ALONG WITH THE REGULAR TRASH AT NO ADDITIONAL COST.

SECTION 4. LOCAL WASTE WILL CONTINUE TO PROVIDE WEEKLY PICK UP AT ALL VILLAGE OWNED BUILDINGS AND THE VILLAGE PARK AT NO ADDITIONAL COST.

SECTION 5. LOCAL WASTE WILL ALSO PROVIDE FREE SERVICE FOR THE VILLAGE FESTIVAL HELD EACH AUGUST AT THE VILLAGE PARK.

SECTION 6. CONTRACT WILL RUN FROM JANUARY 1, 2010 TO DECEMBER 31, 2011.

SECTION 7. BILLING AND COLLECTION FOR TRASH WILL BE DONE BY THE VILLAGE. LOCAL WASTE WILL BILL THE VILLAGE MONTHLY.

SECTION 8. THIS EMERGENCY RESOLUTION SHALL TAKE EFFECT ON JANUARY 1, 2010 AFTER PASSAGE AND SIGNATURES. IT SHALL REMAIN IN FULL FORCE FROM AND AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
