AN EMERGENCY RESOLUTION BY THE VILLAGE OF SOUTH BLOOMFIELD TO ADVANCE MONEY FROM ONE FUND TO ANOTHER FUND

WHEREAS, THE COUNCIL OF THE VILLAGE OF SOUTH BLOOMFIELD WISHES TO ADVANCE MONEY BETWEEN THE WATER DEBT FUND AND THE SEWER DEBT FUND

WHEREAS, IT IS TO THE BENEFIT OF THE VILLAGE TO ADVANCE SAID FUNDS

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE: COUNCIL AUTHORIZES THE ADVANCE OF \$175,000.00 FROM WATER DEBT FUND 5721 INTO THE SEWER DEBT FUND 5277.

SECTION TWO: THIS ADVANCE BEING NECESSARY TO PROVIDE FOR SUFFICIENT FUNDS TO THE SEWER DEBT SERVICE FUND TO MAKE THE JANURARY OWDA DEBT SERVICE PAYMENT AFTER THE ADJUSTMENTS FROM THE RECONCILIATION ADJUSTMENTS OF THE YEAR 2010

SECTION THREE: THIS ADVANCE WILL BE RESPONSIBILITY OF THE SEWER DEBT FUND TO REIMBURSE THE WATER DEBT SERVICE FUND WITHIN A REASONABLE AMOUNT OF FRAME.
